## NRB 2026 International Christian Media Convention Prize Sweepstakes

### Official Rules

Effective 02/17/2026

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE PRIZE IN THIS SWEEPSTAKES. NEITHER BANKING WITH OLD GLORY BANK NOR PURCHASING ANYTHING AT THE *INTERNATIONAL CHRISTIAN MEDIA CONVENTION*, WILL INCREASE YOUR CHANCES OF WINNING. VALID ONLY IN THE UNITED STATES. VOID WHERE PROHIBITED.

#### **ELIGIBILITY:**

To enter this Old Glory Bank NRB Prize Basket Sweepstakes (this "Sweepstakes"), you must, as of the start of the Sweepstakes Period (defined below), be a legal resident of the United States and above the age of majority in your place of residence. Employees, officers, stockholders, and directors of Old Glory Bank and/or National Religious Broadcasters, and their respective parent companies, affiliates, franchisees, subsidiaries and agencies, and their immediate families (parents, siblings, children and spouses of each, regardless of where they live) and members of the households (whether related or not) of such persons are ineligible to participate in this Sweepstakes. The Sweepstakes is subject to all applicable federal, state, and local laws and is void where prohibited.

#### **SWEEPSTAKES PERIOD:**

Entries (described below) must be submitted online between 9:00 AM Central Time on February 18, 2026, and 1:30PM Central Time on February 20, 2026 ("Sweepstakes Period"). Old Glory Bank's digital platform shall serve as the official timekeeper for the Sweepstakes Period.

#### **HOW TO ENTER:**

To enter the Sweepstakes, visit the INTERNATIONAL CHRISTIAN MEDIA CONVENTION, Booth 658, at 2800 Opryland Drive, Nashville, TN 37214, during the Sweepstake Period. Once at the Old Glory Bank Booth, locate a Poster or Flyer that has Old Glory Bank "**Enter to Win**" information and scan the QR code for the Sweepstakes official landing page (the "Official Page").

Once on the Official Page, complete your entry form, and you will be entered into this random Drawing. Old Glory Bank reserves the right to disqualify entries that are incomplete, illegible, contain false or inaccurate information, or are not within the spirit of the Sweepstakes, as determined by Old Glory Bank.

**Entrants must be at the INTERNATIONAL CHRISTIAN MEDIA CONVENTION during the Sweepstakes Period when entering. You may not send the Official Page to others who are not at the INTERNATIONAL CHRISTIAN MEDIA CONVENTION to enter. You do not need to buy anything at the INTERNATIONAL CHRISTIAN MEDIA CONVENTION or do anything, other than enter the Sweepstakes.**

Entrants are limited to one (1) entry per person. Entries must be received during the Sweepstakes Period to be eligible. Any use of automated, robotic, macro, programmed or similar quick-entry programs, or attempts to exceed the maximum number of entries permitted, is prohibited and will result in disqualification. In case of dispute, entries will be declared made by the authorized account holder of the e-mail address submitted at the time of entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet Access Provider, on-line service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted

e-mail address. Old Glory Bank will not verify receipt of entries. Entries become property of Old Glory Bank and will not be returned.

#### **SELECTION AND NOTIFICATION OF THE PRIZE WINNER:**

The Sweepstakes will consist of three drawings that will be conducted by a representative of Old Glory Bank at or about 3:45pm Central Time on February 18, 2026, and at or about 3:45pm Central Time on February 19, 2026, and at or about 1:45pm Central Time on February 20, 2026 (each a "Drawing"). In connection with the Drawing, One (1) potential winner per Drawing will be selected from the eligible entries received. The potential winner(s) will receive a phone call and text message from Old Glory Bank informing him/her that he/she has won the prize.

#### **THE POTENTIAL WINNER WILL BE NOTIFIED BY A PHONE CALL AND TEXT MESSAGE BY 3:46PM CENTRAL TIME ON THE DATE OF EACH OF THE DRAWINGS AND WILL BE REQUIRED TO RESPOND BY ORALLY ACCEPTING OR REPLYING TO SUCH TEXT BY 4:00 PM CENTRAL TIME ON SUCH DATE.**

If such first potential winner does timely reply to such text, then such potential winner will be deemed to irrevocably forfeit such prize, and at about 4:00 PM CT on each Drawing date a second potential winner will be notified. If that second potential winner does not reply to such text message within 15 minutes, then such second potential winner will be deemed to irrevocably forfeit such prize. This process will continue by Old Glory Bank until a potential winner timely replies to such prize.

Except where prohibited by law, potential winners may be required to complete an Affidavit of Eligibility and Liability and Publicity Release (the "Affidavit") at the time of picking up the prize (described below). Non-compliance with these Official Rules, failure to complete all required documentation or Old Glory Bank's inability to contact a potential winner, may result in disqualification. Old Glory Bank's decisions are final and binding in all matters related to this Sweepstakes.

#### **HOW TO COLLECT YOUR PRIZE:**

If you are the winner of the Sweepstakes, you must personally visit the Old Glory Bank Booth 658, at 2800 Opryland Drive, Nashville, TN 37214 by February 20, 2026 to pick-up your prize before the close of the INTERNATIONAL CHRISTIAN MEDIA CONVENTION. You must pay your own expenses to travel to the INTERNATIONAL CHRISTIAN MEDIA CONVENTION to collect your prize. You must verify your identity when picking up your prize. Neither Old Glory Bank nor National Religious Broadcasters will ship or send your prize. In the notice text that you receive as the winner (that you timely reply), there will be a phone number for you to call to coordinate your arrival and pick-up of your prize. If the winner does not timely pick-up such prize at INTERNATIONAL CHRISTIAN MEDIA CONVENTION, then such winner will be deemed to irrevocably forfeit such prize and this Sweepstakes will automatically terminate and no winner will receive the prize.

#### **PRIZE AND APPROXIMATE RETAIL VALUE ("ARV"):**

One winner will be eligible to receive the prize, which is a gift basket of Old Glory Bank merchandise. The retail value of the prize is \$150. Odds of winning the prize depend on the number of eligible entries received prior to the Drawing. No transfer, substitution or cash equivalent for prize is allowed, except at Old Glory Bank's sole discretion. Old Glory Bank reserves the right to substitute a prize, in whole or in part, of equal or greater monetary value if the prize or any portion of the prize cannot be awarded, in whole or in part, as described for any reason. Actual retail value of the prize components may differ from stated ARV and Old Glory Bank will not

award any difference between actual value and ARV. Actual prize may differ from any promotional images. Prize winner is responsible for all federal, state, or local taxes associated with prize acceptance.

#### **DISQUALIFICATION:**

If an entrant is found to be ineligible, or if he/she does not comply with these Official Rules, then such entrant will be disqualified. If the prize, prize documentation or prize notification is returned as undeliverable or unclaimed, this will result in disqualification. In the event an entrant is deemed ineligible or disqualified for any reason under the provisions of the Official Rules, then an alternate potential winner *may* be selected via a random Drawing from among all eligible entries received during the Sweepstakes Period, in Old Glory Bank's sole discretion. If Old Glory Bank is unable to award the prize, the prize may not be re-awarded.

**DISPUTES:**

The Sweepstakes is governed by the laws of Tennessee, without regard to the conflicts of law provisions. All disputes, claims or demands that relate to these Official Rules will first be brought to the attention of the other party and will be resolved individually, without resort to any form of class action. The receiving party shall have sixty (60) days from the date of such notice to remedy the described breach or violation and notify the complaining party in writing of the resolution. If the dispute, claim or demand is not resolved to the satisfaction of the complainant within 60 days, the complainant may request an informal resolution conference (mediation), which if agreed to by the other party will be scheduled to occur within 21 days of the written response. Each party shall have the right to be represented at such a conference by counsel and will ensure that a decision-maker with full and complete authority to resolve the dispute attends the conference. Such conference will be in front of a third party mediator chosen by the parties. If the parties do not agree to conference or are unable to resolve a dispute after such a conference, the parties agree that exclusive jurisdiction for any dispute, claim or demand related in any way to these Official Rules will be decided by binding arbitration. All disputes between the parties, of whatsoever kind or nature arising out of these Official Rules, shall be submitted to JAMS for binding arbitration under its applicable rules then in effect, before one arbitrator to be mutually agreed upon by both parties. The parties agree to share equally in the arbitration costs incurred.
